following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

7. The construction of dam, the material of which it is to be built, and method of protection from waves are as follows: earth fill.

9. The location of outlet from the proposed reservoir, with character of construction and dimensions, are as follows: (All dams across natural stream channels must be provided with an outlet conduit, of such capacity and location to pass the normal flow of the stream at any time)

10. The area submerged by the proposed reservoir, when full, will be .3 acres, with a maximum depth of water of 11 feet; and approximate mean depth of water 4 feet.

11. The estimated cost of the proposed work is \$ 1800.00

12. Construction work will begin on or before 8/9/68

13. Construction work will be completed on or before 8/15/68
