do hereby make application for a permit to construct ~~dam~~ excavated gravel pits ~~reservoir~~ and to store the unappropriated waters of the State of Oregon, subject to existing rights.

1. The name of the stream from which the reservoir is to be filled is two springs and White's Creek tributary to Gales Creek.

2. If not in channel of a stream, state how it is to be filled. springs are adjacent to excavated area; White's Creek requires a diversion dam and 1,200 ft. of 6" pipe, gravity flow

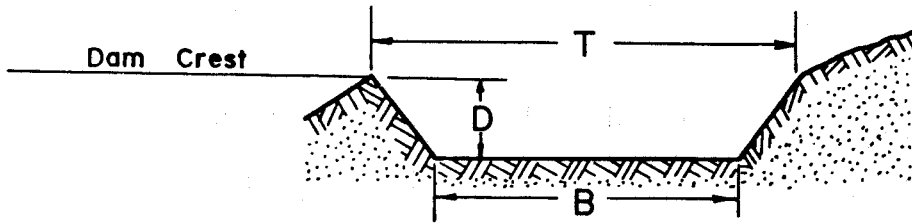



Remarks: the ponds are old gravel pits which fill from springs. I wish to take water from White's Creek to maintain water while irrigating since the ponds will be used for recreation and fish culture. No work needs to be done on these ponds; however, the complete irrigation system has not been purchased. The type of fish in the ponds are catfish, crappies, bluegill, and trout, numbering in the thousands. I am presently working on a lease with the Oregon Department of Fish and Wildlife to allow them use and management of the ponds.


This is to certify that I have examined the foregoing application and do hereby grant the same subject to the following limitations and conditions. The right herein granted is limited to the construction of .3..gravel... pit reservoirs and storage of water from springs in the gravel pits with any deficiency in the available supply from the springs to be made up by diversion from White's Creek, to be appropriated under application No. 49391, permit No. 43206, for irrigation, fish culture, and recreation; being 80 a. f. for irrigation, 20 a. f. for fish culture, and 20 a. f. for recreation.
