and to store the unappropriated waters of the State of Oregon, subject to existing rights.

Spring tributary to East Willis Creek

3. The dam will be located in the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 22,
Township 29 S, Range 6 W, W. M.

4. The maximum height will be 3 feet above stream bed or ground surface at the
centerline. The top width will be 8 feet, slope of upstream face 3:1,
slope of downstream face 2:2, and height of dam above water line when full
2 1/2 feet.

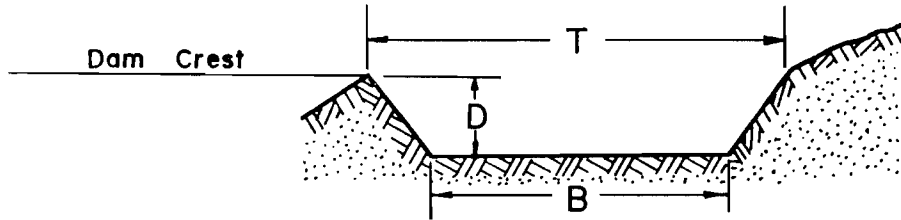
