Application for a Permit to Construct a Reservoir and to Store for Beneficial Use the Unappropriated Waters of the State of Oregon

State of Oregon, do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

1. The name of the proposed reservoir is Short Creek Reservoir 02-R

2. The name of the stream from which the reservoir is to be filled and the appropriation made is Un-named

tributary of Malheur River

3. The amount of water to be stored is 2¹/₂ acre feet.

4. The use to be made of the impounded water is Livestock
(Irrigation, power, domestic supply, etc.)

5. The location of the proposed reservoir will be in Sec. 21

7. The construction of dam, the material of which it is to be built, and method of protection from waves are as follows: Earthfill placement - excavated from catch basin

8. The location of wasteway with dimensions are as follows: Spillway around end of dam; (State whether over or around the dam) Width 12' - depth 4' - length 180'

9. The location of outlet from the proposed reservoir, with character of construction and dimensions, are as follows: None (All dams across natural stream channels must be provided with an outlet conduit, of such capacity and location to pass the normal flow of the stream at any time)

10. The area submerged by the proposed reservoir, when full, will be 0.7 acres, with a maximum depth of water of 9 feet; and approximate mean depth of water 3 feet.

11. The estimated cost of the proposed work is \$ 1,285.00

12. Construction work will begin on or before November 1, 1969

13. Construction work will be completed on or before November 1, 1970

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: The right herein granted is limited to the construction of Short Creek Reservoir and storage of water from an unnamed stream for livestock, and is subject to the installation and maintenance of an outlet pipe, or to provide other means to evacuate the stored water when determined by the Water Resources Director to be necessary to satisfy prior downstream rights.

The right hereunder shall be limited to the storage of 2.1 acre feet.

The priority date of this permit is July 7, 1969

Actual construction work shall begin on or before August 31, 1980 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1981
