do hereby make application for a permit to construct the reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

1. The name of the stream from which the reservoir is to be filled is North Santiam River tributary to Santiam River

2. If not in channel of a stream, state how it is to be filled. there is a ditch from the river to the reservoir site.

3. The dam will be located in the NE 1/4 of the NE 1/4 of Section 21 Township 9S, Range 1E, W. M.

4. The maximum height will be feet above stream bed or ground surface at the centerline. The top width will be feet, slope of upstream face slope of downstream face and height of dam above water line when full feet.

5. The dam will be (check one) earthfill, concrete, flashboard, other. If "other", give description: The reservoir is an excavated area along side an old slough channel. There is no dam structure.




