do hereby make application for a permit to construct the reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

1. The name of the stream from which the reservoir is to be filled is UNNAMED STREAM tributary to PACIFIC OCEAN

2. If not in channel of a stream, state how it is to be filled. From both ground water and diverted streamflow

3. The dam will be located in the SE 1/4 of the SW 1/4 of Section 15 Township 41S, Range 13W, W. M.

4. The maximum height will be 8'-9.9' feet above stream bed or ground surface at the centerline. The top width will be See remarks feet, slope of upstream face, and height of dam above water line when full feet.

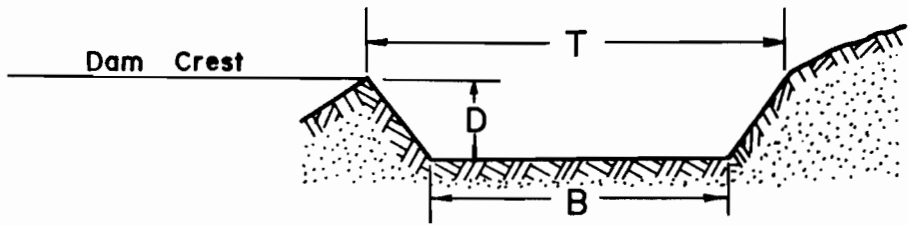


*This is to certify that I have examined the foregoing application and do hereby grant the same subject to the following limitations and conditions. The right herein granted is limited to the construction of reservoirs No. 2 and No. 3 and storage of 1.6 acre feet of water from the unnamed stream in reservoir No. 2 and 2.0 acre feet of water from McVay Creek in reservoir No. 3 to be appropriated under Application No. 57440, Permit No. 44754 for irrigation.*

*The right hereunder shall be limited to the storage of 3.6 acre feet.*

*The priority date of this permit is May 22, 1978 for 1.6 acre feet and October 19, 1978 for 2.0 acre feet*

*Actual construction work shall begin on or before April 9, 1981 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1982.*
