and to store the unappropriated waters of the State of Oregon, subject to existing rights.

1. The name of the stream from which the reservoir is to be filled is Dump Off Joe Cr.
tributary to Rogue River

3. The dam will be located in the SE 1/4 of the NE 1/4 of Section 34,
Township 34 S, Range 6 W, W. M.

4. The maximum height will be 7.5 feet above stream bed or ground surface at the
centerline. The top width will be 40 feet, slope of upstream face 3:1,
slope of downstream face 2:1, and height of dam above water line when full
2.5 feet.

5. The dam will be (check one) earthfill, concrete, flashboard, other.

6. Give the location, description, and dimensions of the outlet conduit: Center of
dam shall be wooden flashboards which will be removable.

of dam will be concrete.




*This is to certify that I have examined the foregoing application and do hereby grant the same subject to the following limitations and conditions. The right herein granted is limited to the construction of
