do hereby make application for a permit to construct the RICE reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

1. The name of the stream from which the reservoir is to be filled is UNNAMED STREAM tributary to SPRING VALLEY CREEK

2. If not in channel of a stream, state how it is to be filled.

3. The dam will be located in the SW 1/4 of the SE 1/4 of Section 23, Township 6 S, Range 4 W, W. M.

4. The maximum height will be 9.8 feet above stream bed or ground surface at the centerline. The top width will be 10 feet, slope of upstream face 3 TO 1, slope of downstream face 2 TO 1, and height of dam above water line when full 4 feet.

5. The dam will be (check one) earthfill, concrete, flashboard, other. If "other", give description:

6. Give the location, description, and dimensions of the outlet conduit: OUTLET CONDUIT IS THROUGH THE CENTER OF THE DAM AT STREAM LEVEL AND CONSISTS OF A 6 INCH DIAMETER PIPE AND VALVE.

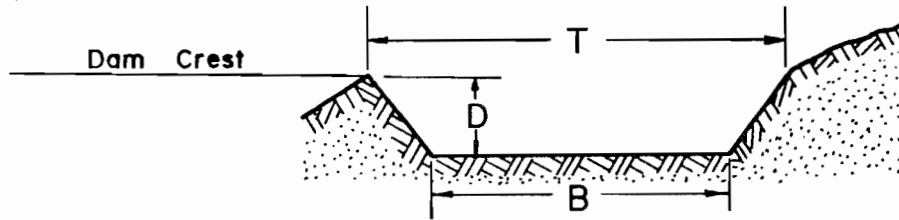

7. The impounded water will be used for IRRIGATION + STOCK WATER

8. The amount of water to be stored is 8.0 acre feet.

9. The area submerged by the reservoir, when full, will be 1.2 acres, and the maximum depth of water will be 12 feet.

10. Give the location and dimensions of the spillway AROUND RIGHT ABUTMENT
(State whether over or around dam)



The bottom width of the spillway, B, will be 10 feet.

The top width of the spillway, T, will be 26 feet.

The distance between the crest of the dam and the crest of the spillway, D, will be 4 feet.
(Must be at least 2 1/2 feet)

If any other type of spillway describe and give dimensions:

THE PRINCIPAL SPILLWAY WILL BE A TRICKLE TUBE ASSEMBLY CONSISTING OF A SIX INCH OUTLET CONDUIT AND RISER. THE EMERGENCY SPILLWAY HAS THE DIMENSIONS GIVEN ABOVE.

11. Construction work will begin on or before AS BUILT

12. Construction work will be completed and the reservoir filled by AS BUILT


