do hereby make application for a permit to construct the reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

1. The name of the stream from which the reservoir is to be filled is UNNAMED STREAM E SURFACE RUN-OFF tributary to ASA SWALE

2. If not in channel of a stream, state how it is to be filled. DRAIN tile under co. RD SUPPLIES SURFACE RUN-OFF. GRAVITY FLOW 4" PIPE FROM UNNAMED CREEK WHEN NEEDED

3. The dam will be located in the SE 1/4 of the NE 1/4 of Section 22 Township 6S, Range 4W, W. M.

4. The maximum height will be 5.0 feet above stream bed or ground surface at the centerline. The top width will be sex below feet, slope of upstream face, slope of downstream face, and height of dam above water line when full feet.

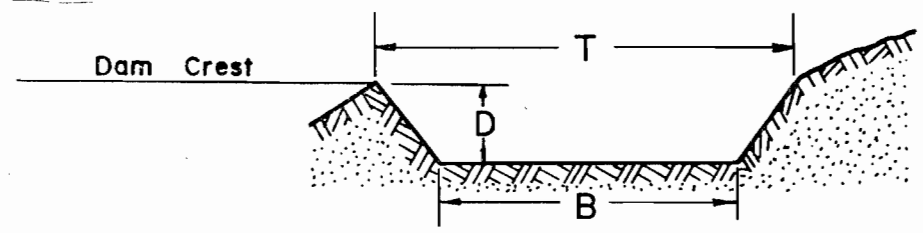


