do hereby make application for a permit to construct the earth filled reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

1. The name of the stream from which the reservoir is to be filled is unnamed streams tributary to Williamson River

2. If not in channel of a stream, state how it is to be filled. I will change the stream channel in channel

3. The dam will be located in the SE 1/4 of the SE 1/4 of Section 10 Township 34 South, Range 7 East of W. M.

4. The maximum height will be 6 feet above stream bed or ground surface at the centerline. The top width will be 8' min feet, slope of upstream face 3:1, slope of downstream face 2:1, and height of dam above water line when full 2 feet.

5. The dam will be (check one) [x] earthfill, concrete, flashboard, other. If "other", give description:

6. Give the location, description, and dimensions of the outlet conduit: The conduit, asphalt dipped corrugated metal pipe will be placed in the center of the dam just above ground level, the conduit valve on the upstream end.

The dimensions of the conduit will be 8" or whatever is required.



9. The area submerged by the reservoir, when full, will be 20 acres, and the maximum depth of water will be 7 feet.

The bottom width of the spillway, B, will be 3 feet.

The top width of the spillway, T, will be 4 feet.

The distance between the crest of the dam and the crest of the spillway, D, will be 2 1/4 feet.
