do hereby make application for a permit to construct the reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

1. The name of the stream from which the reservoir is to be filled is SALT CREEK tributary to S. YAMHILL RIVER

2. If not in channel of a stream, state how it is to be filled. IN CHANNEL

3. The dam will be located in the NE 1/4 of the NW 1/4 of Section 32, Township 55, Range 4 W, W. M.

4. The maximum height will be 6 1/2 feet above stream bed or ground surface at the centerline. The top width will be feet, slope of upstream face VERTICAL, slope of downstream face VERTICAL, and height of dam above water line when full 2 feet.

5. The dam will be (check one) earthfill, concrete, flashboard, other. If "other", give description:

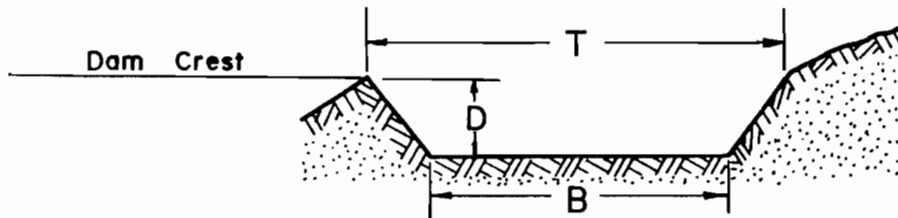

8. The amount of water to be stored is 9.10 acre feet.

9. The area submerged by the reservoir, when full, will be 2.29 acres, and the maximum depth of water will be 7 feet.

10. Give the location and dimensions of the spillway over dam

The bottom width of the spillway, *B*, will be 24 feet.

The top width of the spillway, *T*, will be 24 feet.

The distance between the crest of the dam and the crest of the spillway, *D*, will be 2 feet.
(Must be at least 2½ feet)


The right hereunder shall be limited to the storage of9.1..... acre feet.
