do hereby make application for a permit to construct the unnamed reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

1. The name of the stream from which the reservoir is to be filled is unnamed creek tributary to Willamette River

2. If not in channel of a stream, state how it is to be filled.

3. The dam will be located in the NW 1/4 of the NW 1/4 of Section 27, Township 4 South, Range 3 West, W. M.

4. The maximum height will be 3.0 feet above stream bed or ground surface at the centerline. The top width will be 0.67 feet, slope of upstream face -, slope of downstream face -, and height of dam above water line when full 1.0 feet.

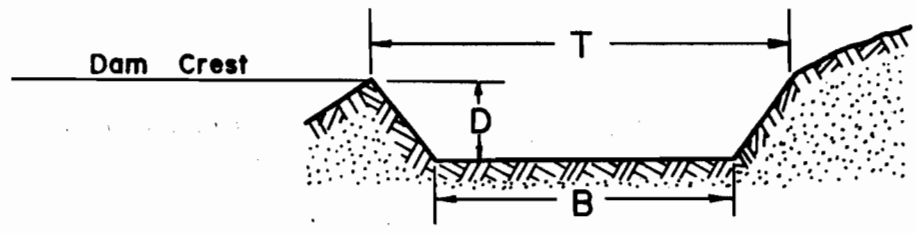


