1. The name of the stream from which the reservoir is to be filled is Price Creek and Unnamed

3. The dam will be located in the W 1/2 of the NW 1/4 of Section 22,

Township 10 S, Range 6 W, W. M.

4. The maximum height will be 33 feet above stream bed or ground surface at the

centerline. The top width will be 14 feet, slope of upstream face 3 : 1,

slope of downstream face 2 : 1, and height of dam above water line when full

3 feet.

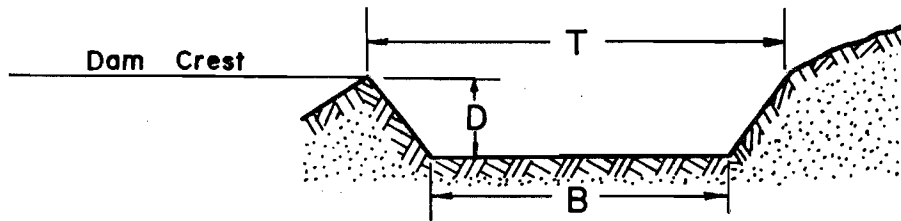

7. The impounded water will be used for Wildlife Habitat and Irrigation being 20.4 A.F. for Wildlife Habitat and 146.0 A.F. for Irrigation.

8. The amount of water to be stored is 166.4 acre feet.

9. The area submerged by the reservoir, when full, will be 19.75 acres, and the maximum depth of water will be 29 feet.

The bottom width of the spillway, B, will be 26 feet.

The top width of the spillway, T, will be 48 feet.

The distance between the crest of the dam and the crest of the spillway, D, will be 3 feet.

Remarks: This reservoir is to be filled from the unnamed stream with any deficiency in the available supply from the unnamed stream to be made up from Price Creek.

The reservoir was constructed under permit R-2862 and will not be changed. The purpose of this application is to apply for Wildlife Habitat rights

on 20.4 A.F. of storage that is being canceled by affidavit and to provide for the filling of the reservoir from Price Creek in the event that there is insufficient run-off in the unnamed stream.


*This is to certify that I have examined the foregoing application and do hereby grant the same subject to the following limitations and conditions. The right herein granted is limited to the construction of ... a reser-

20 .4 acre-feet for wildlife habitat from the unnamed stream with any deficiency in
the available supply from the unnamed stream to be made up by appropriation from
Price Creek, and 146.0 acre-feet for irrigation from Price Creek to augment the
supply available from storage from the unnamed stream under the terms of Permit R-2862.*
