PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION R-63262 and do hereby grant the same SUBJECT TO EXISTING RIGHTS AND THE FOLLOWING LIMITATIONS AND CONDITIONS:

This permit is issued to Rex E. Miller of 700 West Catching Inlet, Coos Bay, Oregon 97420, phone 269-1971, for the construction of two reservoirs and storage of water from three unnamed drainageways to be appropriated under Application 61873, Permit 47295, for irrigation.

The dam will be LOCATED in the: Dam 1 - SW 1/4 SE 1/4; Dam 2 - NW 1/4 SW 1/4 SE 1/4, both of Section 6, Township 26 South, Range 12 West, WM, in the County of Coos.

The maximum height will be feet above the stream bed or ground surface at the centerline. The top width will , slope of upstream face , slope of downstream face , and height of dam above water line when be full *

The area submerged by the reservoir, when full, will be **

The area submerged by the reservoirs, when full, will be 0.7 acre for Reservoir 1 and 0.75 acre for Reservoir 2. The maximum depth of water will be 8.0 feet for Reservoir 1 and 12.0 feet for Reservoir 2.

The location and dimensions of the spillways are: Reservoir 1 - 10-inch pipe across driveway: Reservoir 2 - 5-inch PVC pipe.

The structures are in the channel.

Dam I will be earthfill-concrete based construction and Dam 2 will be earthfill construction.

*The maximum height for Dam I will be 8.0 feet and Dam 2 will be 9.9 feet above streambed or ground surface at the centerline. The top width of Dam 1 will be 150.0 feet and Dam 2 will be 12.0 feet, slope of upstream face for both Dam 1 and Dam 2 will be 3:1, slope of downstream face for both Dam I and Dam 2 will be 3:1, and height of dams above water line when full for Dam I will be 1.0 feet and Dam 2 will be 2.5 feet.

***acre-feet from Unnamed Drainage A and 4.5 acre-feet from Unnamed Drainage B.

The right hereunder shall be limited to the storage of 14.6 acre-feet, being 5.6 acre-feet stored in Reservoir I from Unnamed Drainage I and 9.0 acre-feet stored in Reservoir 2, 4.5*** The PRIORITY DATE of this permit is January 11, 1983

Actual construction work shall begin on or before March 14, 1984 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1985 . Complete application of the water to the proposed use shall be made on or before October 1, 19 86 .
