PERMIT to CONSTRUCT a RESERVOIR and to STORE for BENEFICIAL USE the PUBLIC WATERS

This is to certify that I have examined APPLICATION R-61803 and do hereby grant the same SUBJECT TO EXISTING RIGHTS AND THE FOLLOWING LIMITATIONS AND CONDITIONS:

This permit is issued to On The Way, Incorporated, Paul Winters, President of 4500 Alderwood Drive, Coos Bay, Oregon 97420, phone 640-2888, for the construction of three reservoirs and storage of water from three unnamed streams, tributary Ross Inlet, to be appropriated under Application 61804, Permit 47537 for irrigation,

The dam will be LOCATED in the: NW 1/4 SE 1/4 of Section 18, Township 26 South, Range 12 West, WM, in the County of Coos.

The maximum height will be # feet above the stream bed or ground surface at the centerline. The top width will be ## , slope of upstream face ### , slope of downstream face #### , and height of dam above water line when full 1-2.5 feet, 2-2.5 feet, 3-5.0 feet

The area submerged by the reservoir, when full, will be***** , and the maximum depth of water will be 1-10-0 feet, 2-10-0 feet, 3-7.5 feet

** 1-15 feet, 2-30 feet, 3-30 feet

*** 1-3:1, 2-3:1, 3-3:1

The locations and dimensions of the spillway are: 1 - Around the dam; 2 - Through the dam; 3 - Through the dam. Bottom width 4.0 feet, top width 6.0 feet, the distance between the crest of the dam and the crest of the spillway 2.5 feet.

The location and dimensions of the outlet conduit will be: Through a pipe with an overflow on high side of each dam.

The structures are in the channel.

The dams will be earthfill construction.

The right hereunder shall be limited to the storage of 5.75 acre-feet; being 1.0 acre-foot in Reservoir 1 from Stream 1; 1.0 af in Reservoir 2 from Stream 2; 3.75 af in Reservoir 3 from Stream 3. The PRIORITY DATE of this permit is June 8, 1983

Actual construction work shall begin on or before July 27, 1984 diligence and be completed on or before October 1, 1985.
