This is to certify that I have examined APPLICATION R-65185 and do hereby grant the same SUBJECT TO EXISTING RIGHTS AND THE FOLLOWING LIMITATIONS AND CONDITIONS:

This permit is issued to Jay K. Zieba of 8444 Takilma Road, Cave Junction, Oregon 97523, phone 592-4476, for the construction of a reservoir and storage of water from East Fork Illinois River, a tributary of Illinois River, to be appropriated under Application 64950, Permit 47598 for irrigation,

The dam will be LOCATED in the: SE 1/4 NW 1/4 of Section 26, Township 40 South, Range 8 West, WM, in the County of Josephine.

The maximum height will be 2.0 feet above the stream bed or ground surface at the centerline. The top width will be n/a , slope of upstream face n/a , slope of downstream face n/a , and height of dam above water line when full n/a

The area submerged by the reservoir, when full, will be 1/50 acre , and the maximum depth of water will be 6.0 feet

The locations and dimensions of the spillway are: None

The location and dimensions of the outlet conduit will be: Outlet conduit is 15 feet of 20-inch by 20-inch deep channel constructed of watertight concrete that directs surplus back into the normal flow of the "Wilson Ditch", located approximately 30 feet from inlet. Conduit itself is 4-inch PVC.

The structure is out of the channel.

The dam will be concrete construction. An existing sump hole will be enlarged to approximately 20 feet by 40 feet by 6 feet deep. A rebar steel reinforced frame will support the 25 yards of watertight concrete needed to seal the hole.

The right hereunder shall be limited to the storage of 0.10 acre-feet

day of August

The PRIORITY DATE of this permit is June 9, 1983

Actual construction work shall begin on or before August 25, 1984 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 85 .

Complete application of the water to the proposed use shall be made on or before October 1, 19 n/a.
