PERMIT to CONSTRUCT a RESERVOIR and to STORE for BENEFICIAL USE the PUBLIC WATERS

This is to certify that I have examined APPLICATION R-65236 and do hereby grant the same SUBJECT TO EXISTING RIGHTS AND THE FOLLOWING LIMITATIONS AND CONDITIONS:

This permit is issued to John W. Sweet of 1160 North 10th Street, Coos Bay, Oregon 97420, phone 269-9049, for the construction of two reservoirs and storage of water from an unnamed stream to be appropriated under Application 65044, Permit 47642 for irrigation, frost control and flood harvesting of cranberries, being 9.0 acre-feet for irrigation, 5.0 af for frost control and 9.0 af for flood harvesting provided the total storage shall not exceed 10.8 af.

The dam will be LOCATED in the: Reservoir 1 - NW 1/4 NW 1/4 of Section 31; Reservoir 2 - SE 1/4 NW 1/4 of Section 31, both being within Township 31 South, Range 15 West, WM, in the County of Josephine. CURRY

The maximum height will be # feet above the stream bed or ground surface at the centerline. The top width will be 10.0 feet , slope of upstream face ## , slope of downstream face ### , and height of dam above water line when full 3.0 feet

The area submerged by the reservoir, when full, will be **** , and the maximum depth of water will be 7.0 feet

The locations and dimensions of the spillway are: Reservoir I - bottom width 5.0 feet, top width 7.0 feet, the distance between the crest of the dam and the crest of the spillway 2.5 feet; Reservoir 2 - none. Reservoir 2 us totally excavated.

The location and dimensions of the outlet conduit will be: Reservoir 1 - 3 8-inch diameter PVC pipes extending beyond the base of the dam; Reservoir 2 - has no outlet conduit...

Reservoir 1 is in the channel; Reservoir 2 is out of the channel.

The Dam I will be earthfill construction.

The right hereunder shall be limited to the storage of 10.8 af, being 2.0 af in Reservoir 1 and 8.8 af in Reservoir 2

The PRIORITY DATE of this permit is June 28, 1983

Actual construction work shall begin on or before September 20, 1984 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1985 .
