PERMIT to CONSTRUCT a RESERVOIR and to STORE for BENEFICIAL USE the PUBLIC WATERS

This is to certify that I have examined APPLICATION R-65269 and do hereby grant the same SUBJECT TO EXISTING RIGHTS AND THE FOLLOWING LIMITATIONS AND CONDITIONS:

This permit is issued to Dave H. Brooks, dba Brookhill Farms of Oregon, Route 1, Box 906, Bandon, Oregon 97411, phone 347-9296, for the construction of Reservoirs 2, 6 and 7, and storage of water from Crooked Creek to be appropriated under Application 66058, Permit 47906 for temperature control,

The dam will be LOCATED in the: Pond 2 - NE 1/4 NW 1/4; Pond 6 - NE 1/4 NE 1/4; Pond 7 - NW 1/4 NE 1/4 of Section 18, Township 29 South, Range 14 West, WM, in the County of Coos.

The maximum height will be feet above the stream bed or ground surface at the centerline. The top width will be , slope of upstream face , slope of downstream face , and height of dam above water line when full

The area submerged by the reservoir, when full, will be 1.11 acres , and the maximum depth of water will be

* Pond 2 - 10 feet, Pond 6 - 12.5 feet and Pond 7 - 10.0 feet

The locations and dimensions of the spillway are: None.

The locations and dimensions of the outlet conduits will be: Pond 2 - 6 inch PVC pipe and 8 inch PVC pipe; Pond 6 - none; Pond 7 - 6 inches by 8 inches oblong wood outlet.

The structures are out of the channel.

The reservoirs will be off channel, dug out, flush with ground level.

The right hereunder shall be limited to the storage of 1.6 acre-feet in Reservoir 2; 1.5 acre-feet in Reservoir 7

The PRIORITY DATE of this permit is July 5, 1983

Actual construction work shall begin on or before **December 2, 1984**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **85**.
