## PERMIT to CONSTRUCT a RESERVOIR and to STORE for BENEFICIAL USE the PUBLIC WATERS

This is to certify that I have examined APPLICATION **R-62454** and do hereby grant the same SUBJECT TO EXISTING RIGHTS AND THE FOLLOWING LIMITATIONS AND CONDITIONS:

This permit is issued to **United States, Fremont National Forest of PO Box 551, 34 North D Street, Lakeview, Oregon 97630, phone 947-2151**, for the construction of two stock pond reservoirs and storage of water from an unnamed intermittent stream, tributary to Brown Creek for livestock and is subject to the installation and maintenance of an outlet pipe, or to provide other means to evacuate the stored water when determined by the Water Resources Director to be necessary\*  
The dam will be LOCATED in the: **Reservoir 1 - NE 1/4 SW 1/4; Reservoir 2 - SW 1/4 SW 1/4 of Section 24, Township 37 South, Range 12 East, WM, in the County of Klamath.**

The maximum height will be **\*\*** feet above the stream bed or ground surface at the centerline. The top width will be **\*\*\***, slope of upstream face **each 3:1**, slope of downstream face **each 2:1**, and height of dam above water line when full **2.0 feet each**

The area submerged by the reservoir, when full, will be **\*\*\*\***, and the maximum depth of water will be **4.0 and 3.0 feet**

\* to satisfy prior downstream rights.

\*\* 1 - 3.0 feet; 2 - 4.0 feet

\*\*\* 1 - 8.0 feet; 2 - 3.0 feet

\*\*\*\* 1 - 0.03 acre; 2 - 0.25 acre

The location and dimension of the spillways are: 1 - Around dam with a bottom width 4.0 feet, top width 8.0; 2 - around the dam with a bottom width 2.0 feet, top width 6.0 feet, the distance between the crest of the dams and the crest of the spillways are 2.5 feet each.

The location and dimension of the outlet conduit will be: None.

The structures are in channel.

The dams will be earthfill construction.

The right hereunder shall be limited to the storage of **0.11 acre-foot, being 0.06 af in Reservoir 1 and 0.05 af in Reservoir 2**

The PRIORITY DATE of this permit is **September 4, 1981**.

Actual construction work shall begin on or before **December 20, 1984**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before **October 1, 1985**.
