## PERMIT to CONSTRUCT a RESERVOIR and to STORE for BENEFICIAL USE the PUBLIC WATERS

This is to certify that I have examined APPLICATION **R-62492** and do hereby grant the same SUBJECT TO EXISTING RIGHTS AND THE FOLLOWING LIMITATIONS AND CONDITIONS:

This permit is issued to **United States, Fremont National Forest of PO Box 551, 34 North D Street, Lakeview, Oregon 97630, phone 947-2151**, for the construction of two stock pond reservoirs and storage of water from an unnamed intermittent stream, tributary to Fishhole Creek for livestock and is subject to the installation and maintenance of an outlet pipe, or to provide other means to evacuate the stored water when determined by the Water Resources Director to\*  
The dam will be LOCATED in the: **Reservoir 1 - SE 1/4 NE 1/4 of Section 19, Reservoir 2 - NE 1/4 SW 1/4 of Section 20, Township 37 South, Range 15 East, WM, in the County of Klamath.**

The maximum height will be **\*\*** feet above the stream bed or ground surface at the centerline. The top width will be **\*\*\***, slope of upstream face **each 3:1**, slope of downstream face **each 2:1**, and height of dam above water line when full **each 2.0 feet**

The area submerged by the reservoir, when full, will be **\*\*\*\***, and the maximum depth of water will be **1.0 foot each**

\* be necessary to satisfy prior downstream rights.

\*\* 1 - 3.0 feet; 2 - 6.0 feet

\*\*\* 1 - 1.5 feet; 2 - 3.0 feet

\*\*\*\* 1 - 0.01 acre; 2 - 0.12 acre

The location and dimension of the spillway is: Around dam with a bottom width 1 - 3.0 feet 2 - 6.0 feet, top width 1 - 8.0 feet, 2 - 18 feet, the distance between the crest of the dam and the crest of the spillway 1 - 2.5 feet, 2 - 4 feet.

The location and dimension of the outlet conduit will be: **None.**

The structures are in channel.

The dams will be earthfill construction.

The right hereunder shall be limited to the storage of **0.07 acre-foot, being 0.01 af in Reservoir 1 and 0.06 af in Reservoir 2**

The PRIORITY DATE of this permit is **September 4, 1981**.

Actual construction work shall begin on or before **December 20, 1984**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before **October 1, 1985**.
