PERMIT to CONSTRUCT a RESERVOIR and to STORE for BENEFICIAL USE the PUBLIC WATERS

This is to certify that I have examined APPLICATION R-62495 and do hereby grant the same SUBJECT TO EXISTING RIGHTS AND THE FOLLOWING LIMITATIONS AND CONDITIONS:

This permit is issued to United States, Fremont National Forest of PO Box 551, 34 North D Street, Lakeview, Oregon 97630, phone 947-2151, for the construction of four stock pond reservoirs and storage of water from an unnamed intermittent stream, tributary to Dry Prairie for livestock and are subject to the installation and maintenance of an outlet pipe, or to provide other means to evacuate the stored water when determined by the Water Resources Director to*

The dam will be LOCATED in the: (A) SW 1/4 SW 1/4 of Section 2; (B) NW 1/4 NW 1/4 of Section 11; (C) NW 1/4 NW 1/4 of Section 14; (D) NE 1/4 SE 1/4 of Section 15, Township 38 South, Range 13 East, WM, in the County of Klamath.

The maximum height will be feet above the stream bed or ground surface at the centerline. The top width will be , slope of upstream face each 3:1, slope of downstream face each 2:1, and height of dam above water line when full ***
