PERMIT to CONSTRUCT a RESERVOIR and to STORE for BENEFICIAL USE the PUBLIC WATERS

This is to certify that I have examined APPLICATION **R-67520** and do hereby grant the same SUBJECT TO EXISTING RIGHTS AND THE FOLLOWING LIMITATIONS AND CONDITIONS:

This permit is issued to **Milford B. Bates and Mary K. Bates** of **S. Myrtle Route, Box 226-1, Myrtle Creek, Oregon 97457**, for the construction of a reservoir and storage of water from an unnamed stream to be appropriated under Application 67521, Permit 48250 for irrigation and stock water, and is subject to the installation and maintenance of an outlet pipe, or to provide other means to *

The dam will be LOCATED in the: **NW 1/4 NW 1/4 of Section 22, Township 29 South, Range 4 West, WM, in the County of Douglas.**

The maximum height will be **5.0** feet above the stream bed or ground surface at the centerline. The top width will be **4.0 feet**, slope of upstream face **3:1**, slope of downstream face **2:1**, and height of dam above water line when full **0.5 foot**

The area submerged by the reservoir, when full, will be **0.1 acre**, and the maximum depth of water will be **5.0 feet**

* evacuate the stored water when determined by the Water Resources Director to be necessary to satisfy prior downstream rights.

The location and dimension of the spillway is: Around the dam, bottom width 1.0 foot, top width 4.0 feet, the distance between the crest of the dam and the crest of the spillway 2.5 feet.

The location and dimension of the outlet conduit will be: None.

The structure is in channel.

The dam will be earthfill construction.

The right hereunder shall be limited to the storage of **0.50 acre-foot**, being **0.3 af** for irrigation and **0.2 af** for stock water

The PRIORITY DATE of this permit is **October 12, 1983**

Actual construction work shall begin on or before **March 2, 1985**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before **October 1, 1985**
