PERMIT to CONSTRUCT a RESERVOIR and to STORE for BENEFICIAL USE the PUBLIC WATERS

This is to certify that I have examined APPLICATION R-65571 and do hereby grant the same SUBJECT TO EXISTING RIGHTS AND THE FOLLOWING LIMITATIONS AND CONDITIONS:

This permit is issued to Henry C.W. Inchumuk of PO Box 1548, Cave Junction, Oregon 97523, for the construction of two reservoirs and storage of water from an unnamed stream, a tributary of Montgomery Creek, to be appropriated under Application 65572, Permit 48270 for irrigation and stock water,

The dam will be LOCATED in the: NE 1/4 NE 1/4 of Section 28, Township 38 South, Range 8 West, WM, in the County of Josephine.

The maximum height will be * feet above the stream bed or ground surface at the centerline. The top width will be ** , slope of upstream face 3:1 , slope of downstream face 3:1 , and height of dam above water line when full ***

The area submerged by the reservoir, when full, will be **** , and the maximum depth of water will be 8.0 feet

* for Reservoir 2 for stock water.

** 8.0 feet for both

*** Reservoir 1 - 3.5 feet; Reservoir 2 - 3.0 feet

**** Reservoir 1 - 0.75 acre; Reservoir 2 - 0.5 acre

The location and dimensions of the spillway are: Reservoir 1 - Around the dam, the bottom width of the spillway will be 10.0 feet, the top width of the spillway will be 15.0 feet, the distance between the crest of the dam and the crest of the spillway will be 2.5 feet. Reservoir 2 - Over dam (same dimensions as Reservoir 1).

The dimensions of the outlet conduits will be: 18 inch diversion pipe (steel culvert).

The structures are out of the channel; to be filled by diverting into pipes.

The dams will be earthfill construction.

The right hereunder shall be limited to the storage of 7.5 acre-feet, being 2.5 af for Reservoir 1 and 1.0 af for Reservoir 2 for irrigation, and 2.5 af for Reservoir 1 and 1.5 af *
The PRIORITY DATE of this permit is August 16, 1983 for 5.0 af and September 22, 1983 for 2.5 af

Actual construction work shall begin on or before March 9, 1985 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1985 .
