PERMIT to CONSTRUCT a RESERVOIR and to STORE for BENEFICIAL USE the PUBLIC WATERS

This is to certify that I have examined APPLICATION R-62805 and do hereby grant the same SUBJECT TO EXISTING RIGHTS AND THE FOLLOWING LIMITATIONS AND CONDITIONS:

This permit is issued to US, Fremont National Forest of PO Box 551, Lakeview, Oregon 97630, phone 947-2151, for the construction of two stock pond reservoirs and storage of water from two unnamed intermittent streams, tributary to Chewaucan River for livestock and is subject to the installation and maintenance of an outlet pipe, or to provide other means to evacuate the stored water when determined by the Water *

The dam will be LOCATED in the: (A) SW 1/4 NW 1/4 of Section 2, Township 36 South, Range 18 East, WM; (B) SW 1/4 SW 1/4 of Section 35, Township 35 South, Range 18 East, WM, in the County of Lake.

The maximum height will be ** feet above the stream bed or ground surface at the centerline. The top width will be *** , slope of upstream face each 3:1 , slope of downstream face each 2:1 and height of dam above water line when full ****

The area submerged by the reservoir, when full, will be ***** , and the maximum depth of water will be (A) 4.0 feet; (B) 3.0 feet

* Resources Director to be necessary to satisfy prior downstream rights.

** (A) 3.0; (B) 2.0

*** (A) 4.0 feet; (B) 3.0 feet

**** (A) 3.0 feet; (B) 2.5 feet

***** (A) 0.05 acre; (B) 0.03 acre

The location and dimension of the spillway are: Around dam with a bottom width (A) 2.0 feet; (B) 3.5 feet, top width (A) 9.0 feet; (B) 9.0 feet, the distance between the crest of the dam and the crest of the spillway are: (A) 3.0 feet; (B) 2.5 feet.

The location and dimension of the outlet conduit will be: None.

The structures are in channel.

The dams will be earthfill construction.

The right hereunder shall be limited to the storage of 0.14 acre-foot, being (A) 0.10 af; (B) 0.04 af

The PRIORITY DATE of this permit is August 17, 1983 .

Actual construction work shall begin on or before May 14, 1985 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 86 .
