Street, Lakeview, Oregon 97630, phone 947-2151, for the construction of a stock pond reservoir and storage of water from an unnamed intermittent stream, a tributary of Fishhole Creek for livestock, and is subject to the installation and maintenance of an outlet pipe, or to provide other means to evacuate the stored \*
The dam will be LOCATED in the: NE 1/4 NE 1/4 of Section 15, Township 38 South, Range 14 The dam will be LOCATED in the: NE 1/4 NE East, WM, in the County of Klamath.

The maximum height will be be 2.0 feet feet above the stream bed or ground surface at the centerline. The top width will face 3:1 , slope of downstream face 2:1 , and height of dam above water line when full 2.0 feet slope of upstream face

, and the maximum depth of water will be 3.0 feet 0.03 acre The area submerged by the reservoir, when full, will be

The location and dimensions of the spillway are: Around the dam, the bottom width of the spillway will be 2.0 feet. The top width of the spillway will be 5.0 feet. The distance between the crest of the dam and the crest of the spillway will be 2.5 feet.

The location and dimension of the outlet conduit will be: None.

The structure is in the channel.

The dam will be earthfill construction.

The right hereunder shall be limited to the storage of 0.05 acre-foot

The PRIORITY DATE of this permit is September 4, 1981
