## PERMIT to CONSTRUCT a RESERVOIR and to STORE for BENEFICIAL USE the PUBLIC WATERS

This is to certify that I have examined APPLICATION R-62474 and do hereby grant the same SUBJECT TO EXISTING RIGHTS AND THE FOLLOWING LIMITATIONS AND CONDITIONS:

This permit is issued to United States, Fremont National Forest of PO Box 551, 34 North D Street, Lakeview, Oregon 97630, phone 947-2151, for the construction of 5 stock pond reservoirs and storage of water from unnamed intermittent streams, tributaries of Pole Creek for livestock, and is subject to the installation and maintenance of an outlet pipe, or to provide other means to evacuate the stored water when \*

The dam will be LOCATED in the: Reservoir 1 - SW 1/4 SE 1/4 of Section 31, Township 37 South; Reservoir 2 - NW 1/4 NW 1/4 of Section 4, Township 38 South; Reservoir 3 - SW 1/4 NW 1/4 of Section 5, Township 38 South; Reservoir 4 - SW 1/4 SE 1/4 of \*\*

The maximum height will be \*\*\* feet above the stream bed or ground surface at the centerline. The top width will be \*\*\*\*, slope of upstream face 3:1, slope of downstream face 2:1, and height of dam above water line when full 2.5 feet

The area submerged by the reservoir, when full, will be 8.0 acres, and the maximum depth of water will be 9.0 feet

- \* determined by the Water Resources Director to be necessary to satisfy prior downstream rights.
- \*\* Section 5, Township 38 South; Reservoir 5 - SE 1/4 NE 1/4 of Section 7, Township 38 South, all in Range 14 East, WM, in the County of Klamath.
- \*\*\* Reservoir 1 - 5.0 feet; Reservoir 2 - 2.0 feet; Reservoir 3 - 6.0 feet; Reservoir 4 - 10.0 feet; Reservoir 5 - 6.0 feet.
- \*\*\*\* Reservoir 1 - 5.0 feet; Reservoir 2 - 2.0 feet; Reservoir 3 - 6.0 feet; Reservoir 4 - 3.0 feet; Reservoir 5 - 4.0 feet.

The locations and dimensions of the spillways are: Around the dam, the bottom width of the spillways will be 10.0 feet. The top width of the spillways will be 11.0 feet.

The locations and dimensions of the outlet conduits will be: None.

The structures are in the channel.

The dams will be earthfill construction.

The right hereunder shall be limited to the storage of 0.67 acre-foot, being 0.19 af in Pond 1, 0.01 af in Pond 2, 0.12 af in Pond 3, 0.16 af in Pond 4 and 0.19 af in Pond 5  
The PRIORITY DATE of this permit is September 4, 1981.

Actual construction work shall begin on or before August 14, 1985, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1985.
