PERMIT to CONSTRUCT a RESERVOIR and to STORE for BENEFICIAL USE the PUBLIC WATERS

This is to certify that I have examined APPLICATION R-64888 and do hereby grant the same SUBJECT TO EXISTING RIGHTS AND THE FOLLOWING LIMITATIONS AND CONDITIONS:

This permit is issued to United States, Winema National Forest of PO Box 1390, Klamath Falls, Oregon 97601, phone 883-6714, for the construction of Boot Leg Spring Reservoir and Coyote Spring Reservoir and storage of water from an unnamed intermittent stream, a tributary of Klamath Marsh for livestock, and is subject to the installation and maintenance of an outlet pipe, or to provide other means to $\boldsymbol{\ast}$ The dam will be LOCATED in the: Reservoir 1 - SW 1/4 SE 1/4 of Section 3; Reservoir 2 -NE 1/4 SW 1/4 of Section 9, both within Township 28 South, Range 9 East, WM, in the County of Klamath.

The maximum height will be 2.0 each feet above the stream bed or ground surface at the centerline. The top width will be 5.0 feet each , slope of upstream face 3:1 , slope of downstream face 2:1 , and height of dam above water line when full 2.0 feet each

The area submerged by the reservoir, when full, will be , and the maximum depth of water will be Spring 1 -3.0 feet and Spring 2 - 2.0 feet

- evacuate the stored water when determined by the Water Resources Director to be necessary to satisfy prior downstream rights.
- ** Reservoir 1 0.06 acre and Reservoir 2 0.03 acre

The locations and dimensions of the spillway are: Around the dam, the bottom width of the spillway will be 10.0 feet each. The top width of the spillway will be 10.0feet each. The distance between the crest of the dam and the crest of the spillway will be 2.0 feet each.

The locations and dimensions of the outlet conduits will be: None.

The structures are in the channel.

The dams will be earthfill construction.

The right hereunder shall be limited to the storage of 0.09 acre-foct, being 0.07 af in Boot Leg Spring Reservoir and 0.02 af in Coyote Spring Reservoir The PRIORITY DATE of this permit is February 24, 1983.

Actual construction work shall begin on or before August 14, 1985 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 85 .
