## PERMIT to CONSTRUCT a RESERVOIR and to STORE for BENEFICIAL USE the PUBLIC WATERS

This is to certify that I have examined APPLICATION R-64890 and do hereby grant the same SUBJECT TO EXISTING RIGHTS AND THE FOLLOWING LIMITATIONS AND CONDITIONS:

This permit is issued to United States, Winema National Forest of PO Box 1390, Klamath Falls, Oregon 97601, phone 883-6714, for the construction of 26 Pond Reservoir, 35 Pond Reservoir and Royce Reservoir and storage of water from an unnamed intermittent stream, a tributary of Williamson River for livestock, and is subject to the installation and maintenance of an outlet pipe, or to provide other means to \*

The dam will be LOCATED in the: Reservoir 1 - SE 1/4 SE 1/4 of Section 26; Reservoir 2 - NE 1/4 NW 1/4 of Section 35, Reservoir 3 - SE 1/4 SW 1/4 of Section 35; all being within Township 30 South, Range 10 East, WM, in the County of Klamath.

The maximum height will be \*\* feet above the stream bed or ground surface at the centerline. The top width will be \*\*\* , slope of upstream face 3:1 , slope of downstream face 2:1 , and height of dam above water line when full Reservoir 1 - 2.0 feet each; Reservoir 2 - 3.0 feet each; Reservoir 3 - 2.0 feet each

The area submerged by the reservoir, when full, will be \*\*\*\* , and the maximum depth of water will be Reservoir 1 - 6.0 feet each; Reservoir 2 - 6.0 feet each; Reservoir 3 - 5.0 feet each

- \* evacuate the stored water when determined by the Water Resources Director to be necessary to satisfy prior downstream rights.
- \*\* Reservoir 1 - 2.0 feet; Reservoir 2 - 3.0 feet; Reservoir 3 - 2.0 feet.
- \*\*\* Reservoir 1 - 10.0 feet; Reservoir 2 - 10.0 feet; Reservoir 3 - 8.0 feet.
- \*\*\*\* Reservoir 1 - 0.05 acre; Reservoir 2 - 0.07 acre; Reservoir 3 - 0.05 acre.

The locations and dimensions of the spillways are: None.

The locations and dimensions of the outlet conduits will be: None.

The structures are in the channel.

The dams will be earthfill construction.

The right hereunder shall be limited to the storage of 0.17 acre-foot, being 0.05 af in 26 Pond Reservoir, 0.07 af in 35 Pond Reservoir and 0.05 af in Royce Reservoir  
The PRIORITY DATE of this permit is February 24, 1983.

Actual construction work shall begin on or before August 14, 1985 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 85 .
