PERMIT to CONSTRUCT a RESERVOIR and to STORE for BENEFICIAL USE the PUBLIC WATERS

This is to certify that I have examined APPLICATION R-64937 and do hereby grant the same SUBJECT TO EXISTING RIGHTS AND THE FOLLOWING LIMITATIONS AND CONDITIONS:

This permit is issued to United States, Winema National Forest of PO Box 1390, Klamath Falls, Oregon 97601, phone 883-6714, for the construction of an unnamed reservoir and Sheep Spring Reservoir, and storage of water from God Creek, a tributary of Klamath Marsh for livestock, and is subject to the installation and maintenance of an outlet pipe, or to provide other means to evacuate the stored water when *

The dam will be LOCATED in the: Reservoir 1 - NE 1/4 NW 1/4 of Section 13, Township 29 South, Range 9 East; Reservoir 2 - NW 1/4 NW 1/4 of Section 7, Township 29 South, Range 10 East, WM, in the County of Klamath.

The maximum height will be * feet above the stream bed or ground surface at the centerline. The top width will be 8.0 feet each, slope of upstream face 3:1, slope of downstream face 2:1, and height of dam above water line when full 2.0 feet each

The area submerged by the reservoir, when full, will be 0.05 acre each and the maximum depth of water will be 3.0 feet each

* determined by the Water Resources Director to be necessary to satisfy prior downstream rights.

** Spring 1 - 3.0 feet; Spring 2 - 2.0 feet

The locations and dimensions of the spillways are: Around the dam, the bottom width of the spillways will be 5.0 feet. The distance between the crest of the dams and the crest of the spillways will be 2.0 feet.

The locations and dimensions of the outlet conduits will be: None.

The structures are in the channel.

The dams will be earthfill construction.

The right hereunder shall be limited to the storage of 0.2 acre-foot, being 0.01 af in each reservoir

The PRIORITY DATE of this permit is March 18, 1983

Actual construction work shall begin on or before August 14, 1985, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1985.
