PERMIT to CONSTRUCT a RESERVOIR and to STORE for BENEFICIAL USE the PUBLIC WATERS

This is to certify that I have examined APPLICATION R-64981 and do hereby grant the same SUBJECT TO EXISTING RIGHTS AND THE FOLLOWING LIMITATIONS AND CONDITIONS:

This permit is issued to United States, Winema National Forest of PO Box 1390, Klamath Falls, Oregon 97601, phone 883-6714, for the construction of Ridge Reservoir and Telephone Flat Reservoir, and storage of water from an unnamed intermittent stream, a tributary of Upper Klamath Lake for livestock, and is subject to the installation and maintenance of an outlet pipe, or to provide other means to evacuate the stored*
The dam will be LOCATED in the: Reservoir 1 - NE 1/4 SE 1/4 of Section 7, Township 36 South, Range 8 East; Reservoir 2 - NE 1/4 NE 1/4 of Section 11, Township 36 South, Range 7 East, WM, in the County of Klamath.

The maximum height will be ** feet above the stream bed or ground surface at the centerline. The top width will be *** , slope of upstream face 3:1 , slope of downstream face 2:1 , and height of dam above water line when full 2.0 feet each

The area submerged by the reservoir, when full, will be **** , and the maximum depth of water will be 4.0 feet each

* water when determined by the Water Resources Director to be necessary to satisfy prior downstream rights.

** Reservoir 1 - 3.0 feet; Reservoir 2 - 6.0 feet

*** Reservoir 1 - 5.0 feet; Reservoir 2 - 15.0 feet

**** Reservoir 1 - 0.5 acre; Reservoir 2 - 0.6 acre

The locations and dimensions of the spillways are: Around the dam, the bottom width of the spillways will be Spring 1 - 2.0 feet; Spring 2 - 10.0 feet. The top width of the spillways will be Spring 1 - 4.0 feet; Spring 2 - 12.0 feet. The distance between the crest of the dams and the crest of the spillways will be 3.0 feet each.

The locations and dimensions of the outlet conduits will be: None.

The structures are in the channel.

The dams will be earthfill construction.

The right hereunder shall be limited to the storage of 1.76 acre-feet, being 0.80 af in Ridge Reservoir and 0.96 af in Telephone Flat Reservoir.

The PRIORITY DATE of this permit is April 4, 1983 .

Actual construction work shall begin on or before August 14, 1985 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 85 .
