PERMIT to CONSTRUCT a RESERVOIR and to STORE for BENEFICIAL USE the PUBLIC WATERS

This is to certify that I have examined APPLICATION R-68084 and do hereby grant the same SUBJECT TO EXISTING RIGHTS AND THE FOLLOWING LIMITATIONS AND CONDITIONS:

This permit is issued to Bob Meltebeke of 3324 Regent, Eugene, Oregon 97401, phone 686-0024, for the construction of five reservoirs and storage of water from Daniel's Creek and four drainage swales, tributaries of Muddy Creek, to be maintained under Application 68085, Permit 48680 for stockwater and recreation,

The dam will be LOCATED in the: Reservoir 1 - NW 1/4 NW 1/4 of Section 35; Reservoir 2 - SE 1/4 NW 1/4 of Section 35; Reservoir 3 - SW 1/4 NE 1/4 of Section 35; Reservoir 4 - NE 1/4 NE 1/4 of Section 35; Reservoir 5 - SW 1/4 NW 1/4 of Section 36, all in *
The maximum height will be ** feet above the stream bed or ground surface at the centerline. The top width will be 10.0 feet, slope of upstream face 3:1, slope of downstream face 2:1, and height of dam above water line when full 1.5 feet

The area submerged by the reservoir, when full, will be *** and the maximum depth of water will be ****
* Township 16 South, Range 3 West, WM, in the County of Lane.
** Reservoirs 1, 2, and 4 - 9.0 feet; Reservoirs 3 and 5 - 9.5 feet.
*** Reservoir 1 - 0.44 acre; Reservoir 2 - 1.32 acres; Reservoir 3 - 0.78 acre; Reservoir 4 - 0.29 acre; Reservoir 5 - 0.50 acre.
**** Reservoir 1 - 8.0 feet; Reservoir 2 - 7.0 feet; Reservoir 3 - 7.0 feet; Reservoir 4 - 7.0 feet; Reservoir 5 - 8.0 feet.
***** stockwater and 1.2 af for recreation; 3.3 af from drainage swale 2 and 3.31 af from Daniels Creek in Reservoir 2 of which 1.0 af for stockwater and 5.61 af for recreation; 1.9 af from drainage swale 3 and 2.0 af from Daniels Creek in Reservoir 3 of which 1.0 af for stockwater and 2.9 for recreation; 1.43 af from drainage swale 4 in Reservoir 4 of which 1.0 af for stockwater and 0.43 af for recreation; 2.48 af from Daniels Creek in Reservoir 5 of which 1.0 af for stockwater and 1.48 af for recreation.
***** 1.43 af from drainage swale 4 in Reservoir 4, and July 16, 1984 for storage of 1.10 af from drainage swale 1 in Reservoir 1, for 3.31 af from Daniels Creek in Reservoir 2, 1.90 af from drainage swale 3 in Reservoir 3.

The right hereunder shall be limited to the storage of 16.62 acre-feet, being 1.1 af from drainage swale 1 and 1.1 af from Daniels Creek in Reservoir 1 of which 1.0 af for *****

The PRIORITY DATE of this permit is May 18, 1984 for storage of 5.58 af from Daniels Creek in Reservoirs 1, 3 and 5, and 3.30 af from drainage swale 2 in Reservoir 2, and *****

Actual construction work shall begin on or before August 30, 1985 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 85 .
