

\*APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, Albert M. Thronson, of Molalla, County of Clackamas, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, subject to existing rights:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Woodcock Creek, trib. Milk Creek, a tributary of Molalla River

2. The amount of water which the applicant intends to apply to beneficial use is 0.25 cubic feet per second.

3. The use to which the water is to be applied is irrigation

4. The point of diversion is located 300 ft. N. and 700 ft. W. from the S. 1/4 corner of Sec. 2

being within the SE 1/4 SW 1/4 of Sec. 2, Tp. 5 S, R. 2 E, W. M., in the county of Clackamas

5. The ditch and flume to be about 1500 feet in length, terminating in the SE 1/4 SW 1/4 of Sec. 2, Tp. 5 S, R. 2 E, W. M., the proposed location being shown throughout on the accompanying map.

PERMIT

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.25 cubic feet per second, or its equivalent in case of rotation with other water users, from Woodcock Creek, trib. Milk Creek, trib. Molalla River

The use to which this water is to be applied is irrigation

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is February 19, 1931

Actual construction work shall begin on or before April 3, 1932 and shall thereafter be prosecuted with reasonable diligence and be completed on or before
