

\* APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, Mrs. E. B. Brewer (Name of applicant)

of Myrtle Creek (Postoffice), County of Douglas, State of Oregon

do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, subject to existing rights:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is North Myrtle Creek, tributary of South Umpqua River, a tributary of Umpqua River

2. The amount of water which the applicant intends to apply to beneficial use is 0.1 cubic feet per second.

3. The use to which the water is to be applied is irrigation

4. The point of diversion is located between a point on creek S. 82° 31' E. 1327.4 feet and a point on creek S. 69° 51' 1060.3 feet from the corner common to sections 14, 15, 22, and 23, T. 29 S. R. 5 W. W. M.

**PERMIT**

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.06 cubic feet per second, or its equivalent in case of rotation with other water users, from North Myrtle Creek, tributary of South Umpqua River.

The use to which this water is to be applied is irrigation

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is July 13, 1931

Actual construction work shall begin on or before September 25, 1932 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1933 Extended to Oct. 1, 1935

Complete application of the water to the proposed use shall be made on or before October 1, 1934 Extended to Oct. 1, 1935
