

* APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, Henry F. J. Sieverkropp (Name of applicant) of R.D. #2, Hood River, Oregon, County of Hood River, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, subject to existing rights:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is spring, also seepage and drainage water (Name of stream), a tributary of Hood River.

2. The amount of water which the applicant intends to apply to beneficial use is 0.25 cubic feet per second from one source (If water is to be used from more than one source, give quantity from each)

3. The use to which the water is to be applied is irrigation (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 1600 ft. North and 908 ft. West from the S.E. corner of Section 11, Township 2 North, Range 10 E.W.M. (Section or subdivision) (If preferable, give distance and bearing to Sec. Cor.)

being within the NE 1/4 SE 1/4 of Sec. 11, Tp. 2 North, R. 10 E, W. M., in the county of Hood River (Give smallest legal subdivision) (No. N. or S.) (No. E. or W.)

5. The Ditch or/and pipeline to be (approximately) 600 feet in length, terminating in the E 1/2 of the SE 1/4 of Sec. 11, Tp. 2 N, R. 10 E, W. DIVERSION WORKS—

PERMIT

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.15 cubic feet per second, or its equivalent in case of rotation with other water users, from a spring, also seepage and drainage water, trib. Hood River.

The use to which this water is to be applied is irrigation

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is March 31, 1932

Actual construction work shall begin on or before May 16, 1933 and shall thereafter be prosecuted with reasonable diligence and be completed on or before Oct. 1, 1934

Complete application of the water to the proposed use shall be made on or before Oct. 1, 1935
