

*APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, Frank Stanley Wagner (Name of applicant) of Harbor (Postoffice), County of Curry, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, subject to existing rights:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Spring (Name of stream), a tributary of Chetco River

2. The amount of water which the applicant intends to apply to beneficial use is 1/50 cubic feet per second. (If water is to be used from more than one source, give quantity from each)

**3. The use to which the water is to be applied is domestic garden and berry culture (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 200 ft. N. and 300 ft. W. from the center corner of section 4. (Section or subdivision) (If preferable, give distance and bearing to section corner)

(If there is more than one point of diversion, each must be described. Use separate sheet if necessary.) being within the SE 1/4 SE 1/4 NW 1/4 of Sec. 4, Tp. 41 S, R. 13 W, W. M., in the county of Curry

5. The pipe line to be 3500 feet in length, terminating in the SW 1/4 SW 1/4 of Sec. 4, Tp. 41 S, R. 13 W, W. M., the proposed location being shown throughout on the accompanying map.

DESCRIPTION OF WORKS

DIVERSION WORKS—

6. (a) Height of dam 3 feet, length on top 4 feet, length at bottom 2 1/2 feet; material to be used and character of construction concrete (Loose rock, concrete, masonry, rock and brush, timber crib, etc., wasteway over or around dam)

(c) If water is to be pumped give general description (Size and type of pump) (Size and type of engine or motor to be used, total head water is to be lifted, etc.)

Either of the above forms may be secured, without cost, together with instructions by addressing the State Engineer, Salem, Oregon.

PERMIT

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use measured at the point of diversion from the stream, and shall not exceed .002 cubic feet per second, or its equivalent in case of rotation with other water users, from a spring, trib. Chetco River

The use to which this water is to be applied is irrigation

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is June 19, 1933

Actual construction work shall begin on or before September 9, 1934 and shall thereafter be prosecuted with reasonable diligence and be completed on or before Oct. 1, 1935

Complete application of the water to the proposed use shall be made on or before Oct. 1, 1936
