

\*APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, Dr. F. A. Yoakam (Name of applicant) of Morrpark (Postoffice), County of Los Angeles, State of Calif., do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Unnamed spring branch (Name of stream), a tributary of Siuslaw

2. The amount of water which the applicant intends to apply to beneficial use is 0.05 cubic feet per second. (If water is to be used from more than one source, give quantity from each)

\*\*3. The use to which the water is to be applied is domestic (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located about 1100 ft. N (N. or S.) and 1200 ft. W (E. or W.) from the SE corner of Section 29 (Section or subdivision) (If preferable, give distance and bearing to section corner)

(If there is more than one point of diversion, each must be described. Use separate sheet if necessary) being within the SE 1/4 SE 1/4 (Give smallest legal subdivision) of Sec. 29, Tp. 17 S (N. or S.)

5. The pipe line (Main ditch, canal or pipe line) to be 1000' (Miles or feet) in length, terminating in the SW 1/4 SE 1/4 (Smallest legal subdivision) of Sec. 29, Tp. 17 S (N. or S.)

DESCRIPTION OF WORKS

DIVERSION WORKS—

PERMIT

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to existing rights and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.05 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from an unnamed spring branch, tributary of Siuslaw River

The use to which this water is to be applied is domestic

If for irrigation, this appropriation shall be limited to of one cubic foot per second

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is October 13, 1933

Actual construction work shall begin on or before December 16, 1934 and shall thereafter be prosecuted with reasonable diligence and be completed on or before Oct. 1, 1935

Complete application of the water to the proposed use shall be made on or before Oct. 1, 1936
