\*APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

By We, K. S. Larsen and C. F. Henne (Name of applicant)

of Tidewater (Postoffice), County of Lincoln

State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Bain Creek (Name of stream), a tributary of Alsea River

2. The amount of water which the applicant intends to apply to beneficial use is 0.045 cubic feet per second. (If water is to be used from more than one source, give quantity from each)

\*\*3. The use to which the water is to be applied is irrigation and domestic (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 3730 ft. East and 500 ft. North from the 1/4 corner of between Sec. 31 and 32, T. 13 S., R. 10 W. (Section or subdivision) (If preferable, give distance and bearing to section corner)

DESCRIPTION OF WORKS

DIVERSION WORKS—

PERMIT

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to existing rights and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.045 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Bain Creek

The use to which this water is to be applied is irrigation and domestic

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated.

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is November 16, 1933

Actual construction work shall begin on or before December 16, 1934 and shall thereafter be prosecuted with reasonable diligence and be completed on or before Oct. 1, 1935

Complete application of the water to the proposed use shall be made on or before Oct. 1, 1936
