

\*APPLICATION FOR A PERMIT

To Appropriate the Public Waters of the State of Oregon

I, S. A. Gouthier (Name of applicant) of Wonder (Postoffice), County of Josephine, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, subject to existing rights:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Water-dog Creek (Name of stream), a tributary of Illinois River

2. The amount of water which the applicant intends to apply to beneficial use is 2.0 cubic feet per second. (If water is to be used from more than one source, give quantity from each)

\*\*3. The use to which the water is to be applied is mining (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 2000 ft. N and 150 ft. W from the S1/4 corner of Section 36, T. 36 S., R. 9 W W.M. (Section or subdivision) (If preferable, give distance and bearing to section corner)

(If there is more than one point of diversion, each must be described. Use separate sheet if necessary.) being within the NE1/4 SW1/4 of Sec. 36, Tp. 36 S, R. 9 W, W. M., in the county of Josephine (Give smallest legal subdivision) (E. or W.)

5. The ditch and flume to be 1 1/4 miles (Main ditch, canal or pipe line) (Miles or feet) in length, terminating in the SE1/4 NE1/4 of Sec. 35, Tp. 36 S, R. 9 W, W. M., the proposed location being shown throughout on the accompanying map. (Smallest legal subdivision) (E. or W.) (N. or S.)

DESCRIPTION OF WORKS

DIVERSION WORKS—

6. (a) Height of dam 5 feet, length on top 10 feet, length at bottom 10 feet; material to be used and character of construction Timber dam. Plank facing. Wasteway over (Loose rock, concrete, masonry, rock and brush, timber crib, etc., wasteway over or around dam)

PERMIT

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 2.0 measured at the point of diversion from the stream, cubic feet per second/or its equivalent in case of rotation with other water users, from Water-dog Creek

The use to which this water is to be applied is mining

If for irrigation, this appropriation shall be limited to of one cubic foot per second or its equivalent for each acre irrigated and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is August 16, 1934

Actual construction work shall begin on or before September 28, 1935 and shall thereafter be prosecuted with reasonable diligence and be completed on or before Oct. 1, 1936

Complete application of the water to the proposed use shall be made on or before Oct. 1, 1937
