

*APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

We, Huron W. and Bess A. Clough (Name of applicant)

of Canyonville (Postoffice), County of Douglas,

State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation Partnership operating an estate since 1919.

1. The source of the proposed appropriation is Clough Creek (Name of stream), a tributary of South Umpqua

2. The amount of water which the applicant intends to apply to beneficial use is minimum of 4 gal. per minute (If water is to be used from more than one source, give quantity from each)

**3. The use to which the water is to be applied is domestic supplies yard and garden (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 1500 ft. W and 100 ft. S from the SW corner of 7 and 18 on the Township line 30 South Range 4 W (Section or subdivision) (If preferable, give distance and bearing to section corner)

(If there is more than one point of diversion, each must be described. Use separate sheet if necessary) being within the NW 1/4 NE 1/4 of Sec. 13, Tp. 30 S, R. 5 W, W. M., in the county of Douglas (Give smallest legal subdivision) (N. or S.)

5. The pipe line to be 3300 (Main ditch, canal or pipe line) (Miles or feet) in length, terminating in the NW 1/4 NW 1/4 of Sec. 18, Tp. 30 S, R. 4 W, W. M., the proposed location being shown throughout on the accompanying map. (Smallest legal subdivision) (N. or S.)

DESCRIPTION OF WORKS

DIVERSION WORKS—

6. (a) Height of dam 4 feet, length on top 12 feet, length at bottom 6 feet; material to be used and character of construction concrete and rock (Loose rock, concrete, masonry, rock and brush, timber crib, etc., wasteway over or around dam)

PERMIT

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to existing rights and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.01 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from

Clough Creek

The use to which this water is to be applied is Domestic, including the irrigation of a domestic garden not exceeding 1/2 acre in area

If for irrigation, this appropriation shall be limited to of one cubic foot per second

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is May 29, 1935

Actual construction work shall begin on or before August 15, 1936 and shall thereafter be prosecuted with reasonable diligence and be completed on or before Oct. 1, 1937

Complete application of the water to the proposed use shall be made on or before Oct. 1, 1938
