

*APPLICATION FOR A PERMIT

CERTIFICATE NO. 14368

To appropriate the Public Waters of the State of Oregon

I, W. H. Wallis (Name of applicant) of Route 1, Ashland (Postoffice), County of Jackson, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Jenny Creek (Name of stream), a tributary of Klamath River

2. The amount of water which the applicant intends to apply to beneficial use is 0.56 cubic feet per second. (If water is to be used from more than one source, give quantity from each)

**3. The use to which the water is to be applied is irrigation (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located N 20° W 2400 ft. ft. and ft. from the NW Section corner of Section 22 (Section or subdivision)

5. The main ditch to be 1 1/4 miles (Main ditch, canal or pipe line) (Miles or feet) in length, terminating in the NW 1/4 NW 1/4 of Sec. 27, Tp. 40 S, R. 4 E, W. M., the proposed location being shown throughout on the accompanying map. (Smallest legal subdivision) (N. or S.) (E. or W.)

DESCRIPTION OF WORKS

DIVERSION WORKS—

6. (a) Height of dam 1.5 feet, length on top 20 feet, length at bottom feet; material to be used and character of construction dirt and rock (Loose rock, concrete, masonry, rock and brush, timber crib, etc., wasteway over or around dam)

PERMIT

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to existing rights and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.56 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Jenny Creek

The use to which this water is to be applied is Irrigation

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is July 8, 1935

Actual construction work shall begin on or before August 15, 1936 and shall thereafter be prosecuted with reasonable diligence and be completed on or before

Oct. 1, 1937 Extended to Oct. 1, 1939 Extended to Oct. 1, 1940 Extended to Oct. 1, 1941
