

**\*APPLICATION FOR A PERMIT**

**To Appropriate the Public Waters of the State of Oregon**

I, E. F. Straughan (Name of applicant)  
of Pendleton (Postoffice), County of Umatilla  
State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, **SUBJECT TO EXISTING RIGHTS:**

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Birch Creek (Name of stream), a tributary of Umatilla River

2. The amount of water which the applicant intends to apply to beneficial use is 0.5 cubic feet per second. (If water is to be used from more than one source, give quantity from each)

\*\*3. The use to which the water is to be applied is Irrigation (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 5 ft. N and 1090 ft. East from the 1/4 corner of Section 32 and 33 (Section or subdivision)  
(If preferable, give distance and bearing to section corner)

being within the SW 1/4 NW 1/4 of Sec. 33, Tp. 2 N, R. 32 E, W. M., in the county of Umatilla (Give smallest legal subdivision) (N. or S.) (E. or W.)

5. The Ditch (Main ditch, canal or pipe line) to be Three-Fourth Mile (Miles or feet) in length, terminating in the NW 1/4 SE 1/4 of Sec. 29, Tp. 2 N, R. 32 E, W. M., the proposed location being shown throughout on the accompanying map. (Smallest legal subdivision) (N. or S.) (E. or W.)

**DESCRIPTION OF WORKS**

**DIVERSION WORKS—**

6. (a) Height of dam 3 feet, length on top 35 feet, length at bottom 30 feet; material to be used and character of construction Loose Rock (Loose rock, concrete, masonry, rock and brush, timber crib, etc., wasteway over or around dam)  
**This dam is one used by the Straughan decreed right and is already completed.**

(b) Description of headgate Concrete (Timber, concrete, etc., number and size of openings)  
18 x 24 inch

(c) If water is to be pumped give general description (Size and type of pump)  
(Size and type of engine or motor to be used, total head water is to be lifted, etc.)

PERMIT

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to existing rights and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.50 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from

Birch Creek

The use to which this water is to be applied is Irrigation

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is January 22, 1936

Actual construction work shall begin on or before March 27, 1937 and shall thereafter be prosecuted with reasonable diligence and be completed on or before Oct. 1, 1938

Complete application of the water to the proposed use shall be made on or before Oct. 1, 1939
