

\*APPLICATION FOR A PERMIT

CERTIFICATE NO. 14343

To appropriate the Public Waters of the State of Oregon

I, M. Callahan and Hugh Callahan (Name of applicant) of Gaston (Postoffice), County of Washington State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Tualatin River (Name of stream), a tributary of Willamette River

2. The amount of water which the applicant intends to apply to beneficial use is 1/4 cubic feet per second. (If water is to be used from more than one source, give quantity from each)

\*\*3. The use to which the water is to be applied is Irrigation (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 1400 ft. S (N. or S.) and 300 ft. W (E. or W.) from the NE corner of SE 1/4 of Sec. 32 T. 1 S., R. 4 W. (Section or subdivision)

being within the SE 1/4 SE 1/4 of Sec. 32, Tp. 1 S. (N. or S.), R. 4 W. (E. or W.), W. M., in the county of Washington and the W 1/2 of the SW 1/4 of Sec. 33

5. The main ditch (Main ditch, canal or pipe line) to be 300 (Miles or feet) in length, terminating in the SW 1/4 (Smallest legal subdivision) of Sec. 33, Tp. 1 S. (N. or S.), R. 4 W. (E. or W.), W. M., the proposed location being shown throughout on the accompanying map.

PERMIT

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to existing rights and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.25 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from

Tualatin River

The use to which this water is to be applied is Irrigation

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is March 18, 1936

Actual construction work shall begin on or before May 29, 1937 and shall thereafter be prosecuted with reasonable diligence and be completed on or before Oct. 1, 1938 Extended 10-1-40

Complete application of the water to the proposed use shall be made on or before Oct. 1, 1939 Extended to 10-1-40
