PERMIT

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use measured at the point of diversion from the stream, and shall not exceed 0.53 cubic feet per second, or its equivalent in case of rotation with other water users, from spring branch and springs and waste water.

The use to which this water is to be applied is irrigation. If for irrigation this appropriation shall be limited to 1/40th of one cubic foot per second or its equivalent for each acre irrigated during the irrigation season from April 1, to October 1, and shall be further limited to a diversion of not to exceed 1 acre foot per acre for each acre irrigated during the month of July, 1 acre foot per acre for each acre irrigated during the month of August, and 1/2 acre foot per acre for each acre irrigated during the month of September, and is also limited to the water available at the proposed point of diversion and does not carry with it the right to divert water from the stream from which the waste water is diverted nor the right to require the wasteful use of water by others, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is April 8, 1936

Actual construction work shall begin on or before May 29, 1937 and shall thereafter be prosecuted with reasonable diligence and be completed on or before Oct. 1, 1938

Complete application of the water to the proposed use shall be made on or before Oct. 1, 1939
