

*APPLICATION FOR A PERMIT

CERTIFICATE NO. 12143

To appropriate the Public Waters of the State of Oregon

I, Charles W. Hughey (Name of applicant) of 17 S.E. Third Ave. Portland (Postoffice), County of Oregon, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Unnamed spring (Name of stream), a tributary of Willamette River

2. The amount of water which the applicant intends to apply to beneficial use is .003 cubic feet per second. (If water is to be used from more than one source, give quantity from each)

**3. The use to which the water is to be applied is irrigation of a garden and lawn and use in pool (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 300 ft. N and 480 ft. E from the SW corner of NW 1/4 SW 1/4 Section 7 (Section or subdivision) (If preferable, give distance and bearing to section corner)

5. The pipe line (Main ditch, canal or pipe line) to be 500+ (Miles or feet) in length, terminating in the NW 1/4 SW 1/4 of Sec. 7, Tp. 2 S, R. 2 E, W. M., the proposed location being shown throughout on the accompanying map. (Smallest legal subdivision) (N. or S.) (E. or W.)

DESCRIPTION OF WORKS

DIVERSION WORKS—

PERMIT

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to existing rights and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.03 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from unnamed spring

The use to which this water is to be applied is irrigation of a garden not exceeding two acres in area, and a pool

If for irrigation, this appropriation shall be limited to of one cubic foot per second

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is June 30, 1936

Actual construction work shall begin on or before October 15, 1937 and shall thereafter be prosecuted with reasonable diligence and be completed on or before Oct. 1, 1938

Complete application of the water to the proposed use shall be made on or before Oct. 1, 1939
