To appropriate the Public Waters of the State of Oregon

I, The Clark and Wilson Lumber Company of Delaware

do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation Nov. 9th, 1927, State of Delaware

1. The source of the proposed appropriation is Cedar Creek (Name of stream), a tributary of Nehalem River

2. The amount of water which the applicant intends to apply to beneficial use is 1.0 cubic feet per second. (If water is to be used from more than one source, give quantity from each)

**3. The use to which the water is to be applied is Railroad, logging and domestic (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 3110.7ft. N (N. or S.) and 1279 ft. E (E. or W.) from the 1/4 corner of common to Sec. 34, T. 6 N., R. 4 W.W.M. and Sec. 3, T. 5 N., R. 4 W.W.M. (Section or subdivision) (If preferable, give distance and bearing to section corner)

PERMIT

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to existing rights and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.0 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Cedar Creek

The use to which this water is to be applied is Railroad, logging and domestic, being 0.95 sec. ft. for railroad and logging purposes and 0.05 sec. ft. for domestic

If for irrigation, this appropriation shall be limited to of one cubic foot per second

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is July 1, 1936

Actual construction work shall begin on or before September 5, 1937 and shall thereafter be prosecuted with reasonable diligence and be completed on or before Oct. 1, 1938

Complete application of the water to the proposed use shall be made on or before Oct. 1, 1939
