APPLICATION FOR A PERMIT TO APPROPRIATE THE PUBLIC WATERS OF THE STATE OF OREGON

I, Joseph Vey (Name of Applicant)

of Pendleton, County of Umatilla (Postoffice)

State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, subject to existing rights:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Umatilla River (Name of stream)

2. The amount of water which the applicant intends to apply to beneficial use is 3 cubic feet per second.

3. The use to which the water is to be applied is Irrigation (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located N 75° E 120 feet distant from the SE corner of the SW 1/4 of Section 6 T 2 N R 33 E.W.M. (Give distance and bearing to section corner)

being within the SW 1/4 of SE 1/4 of Sec. 6, Tp. 2 N, R. 33 E, Umatilla (Give smallest legal subdivision) (No. N. or S.) (No. E. or W.)

5. The ditch to be 3/4 miles in length, terminating in the SE 1/4 SE 1/4 of Sec. 1, Tp. 2 N, R. 32 E (Main ditch, canal or pipe line) (Smallest legal subdivision) (No. N. or S.) (No. E. or W.)

W. M., the proposed location being shown throughout on the accompanying map.

6. The name of the ditch, canal or other works is Joseph Vey Ditch

Diversion Works—

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: The appropriation for irrigation purposes shall be limited to one-eightieth of one cu. ft. per sec. for each acre irrigated. The use hereunder shall conform to any reasonable rotation system ordered by the proper State officers.

The priority date of this permit is June 14, 1912

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 1 & 28/100 (1.28) cubic feet per second. or its equivalent in case of rotation

Actual construction work shall begin on or before July 22, 1913

and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1914

Complete application of the water to the proposed use shall be made on or before October 1, 1915
