

*APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, L. S. Mattoon (Name of applicant) of La Grande (Postoffice), County of Oregon, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Mill Creek (Name of stream), a tributary of Grande Ronde River

2. The amount of water which the applicant intends to apply to beneficial use is 0.28 cubic feet per second. (If water is to be used from more than one source, give quantity from each)

**3. The use to which the water is to be applied is Irrigation and stock (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 810 ft. north and 320 ft. west from the SW corner of SE 1/4 SW 1/4 Sec. 8. (Section or subdivision)

The point of Upper diversion is located about 740 ft. N., and 50 ft. E of SW corner of SE 1/4 SW 1/4 Sec. 8. (If preferable, give distance and bearing to section corner)

being within the SE 1/4 SW 1/4 of Sec. 8, Tp. 3 S., R. 33 E., W. M., in the county of Union (Give smallest legal subdivision) (N. or S.)

5. The Upper ditch Lower ditch to be 1300 ft. 2400 ft. (Main ditch, canal or pipe line) (Miles or feet) in length, terminating in the SE 1/4 SW 1/4 of Sec. 8, Tp. 3 S., R. 33 E., W. M., the proposed location being shown throughout on the accompanying map. (Smallest legal subdivision) (N. or S.)

DESCRIPTION OF WORKS

DIVERSION WORKS—

PERMIT

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to existing rights and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.28 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from

Mill Creek

The use to which this water is to be applied is Irrigation and stock, being 0.23 c.f.s. for irrigation and 0.05 c.f.s. for stock

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated throughout the irrigation season,

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is November 20, 1936.

Actual construction work shall begin on or before January 8, 1938 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1938

Complete application of the water to the proposed use shall be made on or before

October 1, 1939.
