\*APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, Clackamas County (Name of applicant) of Oregon City (Postoffice), County of Clackamas, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Unnamed stream (Name of stream), a tributary of Clackamas River

2. The amount of water which the applicant intends to apply to beneficial use is 1.0 cubic feet per second. (If water is to be used from more than one source, give quantity from each)

\*\*3. The use to which the water is to be applied is Manufacturing (cleaning crushed rock) (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 180 ft. South and 15 ft. West from the NW corner of NE 1/4 NE 1/4, Section 20, T. 2 S., R. 3 E., W. M. (Section or subdivision) (If preferable, give distance and bearing to section corner)

(If there is more than one point of diversion, each must be described. Use separate sheet if necessary) being within the Lot 2 (NW 1/4 of NE 1/4) Sec. 20 of Sec. 20, Tp. 2 S., R. 3 E., W. M., in the county of Clackamas (Give smallest legal subdivision) (N. or S.) (E. or W.)

5. The Pipe line to be 1000 feet (Main ditch, canal or pipe line) (Miles or feet) in length, terminating in the SE 1/4 SE 1/4 of Sec. 17, Tp. 2 S., R. 3 E., W. M., the proposed location being shown throughout on the accompanying map. (Smallest legal subdivision) (N. or S.) (E. or W.)

DESCRIPTION OF WORKS

DIVERSION WORKS— Sump to be used - No dam required

6. (a) Height of dam feet, length on top feet, length at bottom feet; material to be used and character of construction (Loose rock, concrete, masonry, rock and brush, timber crib, etc., wasteway over or around dam)

(b) Description of headgate (Timber, concrete, etc., number and size of openings)

(c) If water is to be pumped give general description 5 1/2" by 10" stroke (Size and type of pump) Fairbanks Double stroke pump (Size and type of engine or motor to be used, total head water is to be lifted, etc.) Westinghouse D. C. 110 Volt. 20 H.P. Motor 150# pressure at pump - 40# at Bunkers.

\* A different form of application is provided where storage works are contemplated.

\*\* Applications for permits to appropriate water for the generation of electricity, with the exception of municipalities, must be made to the Hydroelectric Commission. Either of the above forms may be secured, without cost, together with instructions by addressing the State Engineer, Salem, Oregon.

PERMIT

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to existing rights and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.0 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Unnamed Stream

The use to which this water is to be applied is Manufacturing

If for irrigation, this appropriation shall be limited to of one cubic foot per second

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is February 16, 1938

Actual construction work shall begin on or before May 31, 1939 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1940

Complete application of the water to the proposed use shall be made on or before October 1, 1941
