

*APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, Victor Olsen (Name of applicant) of Merlin (Postoffice), County of Josephine State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Hog Creek (Name of stream), a tributary of Rogue River

2. The amount of water which the applicant intends to apply to beneficial use is 1.5 sec. ft. cubic feet per second. 1.0 sec. ft. for mining, 0.50 sec. ft. for irrigation. (If water is to be used from more than one source, give quantity from each)

**3. The use to which the water is to be applied is Irrigation and Mining (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 580 ft. North and 300 ft. West from the E 1/4 corner of Section 2, T. 35 S., R. 7 W., W. M., (Section or subdivision)

(If preferable, give distance and bearing to section corner)

being within the SE 1/4 NE 1/4 of Sec. 2, Tp. 35 S., R. 7 W., W. M., in the county of Josephine

5. The flume and ditch to be 2 miles in length, terminating in the SW 1/4 NW 1/4 of Sec. 14, Tp. 35 S., R. 7 W., W. M., the proposed location being shown throughout on the accompanying map.

DESCRIPTION OF WORKS

DIVERSION WORKS—

6. (a) Height of dam 4 feet, length on top 20 feet, length at bottom 20 feet; material to be used and character of construction Log crib. Plank facing. Wasteway over rock and brush, timber crib, etc., wasteway over or around dam

PERMIT

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to existing rights and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.5 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Hog Creek

The use to which this water is to be applied is Irrigation and Mining, being 0.50 c.f.s. for irrigation and 1.0 c.f.s. for mining

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is April 5, 1938

Actual construction work shall begin on or before May 31, 1939 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1940

Complete application of the water to the proposed use shall be made on or before October 1, 1941
