

\*APPLICATION FOR A PERMIT CERTIFICATE NO. 14437

To appropriate the Public Waters of the State of Oregon

I, Daniel Wohlgemuth (Name of applicant) of Route 2, Newberg (Postoffice), County of Yamhill, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Spring Brook (Name of stream), a tributary of Willamette River

2. The amount of water which the applicant intends to apply to beneficial use is 0.38 cubic feet per second. (If water is to be used from more than one source, give quantity from each)

\*\*3. The use to which the water is to be applied is Irrigation (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located along stream on applicant's property within ft. and ft. from the corner of NW 1/4 NE 1/4 and NE 1/4 NW 1/4, Section 33, (Section or subdivision) (If preferable, give distance and bearing to section corner)

5. The Pipe Line to be 500 ft. in length, terminating in the NW 1/4 NE 1/4 and NE 1/4 NW 1/4 of Sec. 33, Tp. 3 S., R. 2 W., W. M., the proposed location being shown throughout on the accompanying map. (Main ditch, canal or pipe line) (Miles or feet) (Smallest legal subdivision) (E. or W.)

DESCRIPTION OF WORKS

DIVERSION WORKS—

PERMIT

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to existing rights and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.38 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Spring Brook

The use to which this water is to be applied is Irrigation

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is August 11, 1938

Actual construction work shall begin on or before November 28, 1939 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1940 (Extended to Oct. 1, 1941)

Complete application of the water to the proposed use shall be made on or before October 1, 1941
